President's Message

On behalf of WMCA, it was a pleasure to attend the annual conference of the City Clerk's Association of California

(CCAC). Not only did I enjoy beautiful weather, but it was nice to hear that the weather in Washington was just as beautiful that week. The CCAC conference was fun, informative, and provided a great opportunity to network with our California clerks. It was reassuring to learn that we have so much in common with our neighbors to the south, and that clerks face the same kinds of challeng-

es no matter where you go. I definitely got some new ideas for things I want to seek, as well as things I want to destroy.

The conference featured speakers covering a wide variety of topics and issues relevant to the clerk profession. Dr. De Hicks provided valuable insights on how to create clarity about your values, mission and purpose. The big takeaway was understand the "why" behind your organization and how to use that understanding to gain wisdom about what matters and what doesn't. There was also an excellent leadership session which provided tools to overcome the obstacles that prevent some clerks from playing larger roles in their organizations. Clerks were encouraged to walk the talk and to earn the respect they need to be transformative in their cities.

For the nerds like me interested in



technology and electronically stored information (ESI), there was a session covering topics ranging from recommended processes and procedures to identify relevant technologies, to developing a trust-

worthy ECM/EDMS system. Another session covered smart phone and tablet apps that can save organizations time and money, all while building community and leveraging content. There was also a technical training session on how to incorporate Adobe Acrobat into daily practices such as certifying records and creating digital agenda packages. Another fun and interactive session high-

lighted the difference between "analog" and "digital" media forms and discussed life expectancy of paper, microfilm and digital media.
