LEGISLATIVE NEWS YOU CAN USE

In the City of Pasco, Roger Lenk has requested years of records from Councilmembers Rebecca Francik, Saul Martinez, and Mike Garrison, Mayor Matt Watkins, City Manager Gary Crutchfield, and Fire Chief Bob Gear, as well as other numerous requests. The city scheduled the release of records through 2016 and the schedule was approved by Judge Bruce Spanner.



Early in October, the City of Pasco celebrated a court victory by presenting a paper copy of an email that Lenk accused the City of withholding, even after receiving over 10,000 emails involving Councilmembers Rebecca Francik and Saul Martinez. The two councilmembers, Francik and Martinez, voted last year to annex part of the area known as the 'doughnut hole'.

The City has provided over 120,000 pages of documents to Lenk. Roger Lenk is a county resident who has helped lead the fight for two ballot propositions that would change the city's form of government and eliminate two recent annexations. City staff has spent an estimated 900 hours working on Lenk's requests at a cost of \$46,800 plus another \$120,000 in attorney fees.

Superior Court Judge Sal Mendoza Jr. dismissed a public records lawsuit filed by Lenk against the City. Mendoza ruled the city properly responded to Lenk's requests for emails to and from Francik and Martinez on their personal and government accounts. All cities can take this decision as a message that there is hope in that the court system is upholding "production schedules" and "reasonable email search" – two major items that assist a city's defense against lawsuits.

The agenda for the meeting included review of the 2013 Professional Development Institute program, 2013-2014 budget review and approval, selection of a presenter for the 2014 Professional Development IV session, and review of a draft RFQ for a new Institute Director.

Yes, it is with a saddened heart that our dear Dema Harris, Northwest Institute Director, will be retiring following the 2014 Professional Development program. Dema has worked with WMCA Past President and Former Education Committee Chair Ali Spietz to prepare an RFQ that will be ready for distribution by the first of the year. Dema's passion for education, her dedication to our professional development, and her motherly attention to all will be truly missed. She has touched the professional lives of over 1,000 Clerks and Recorders during her tenure as our Institute Director.

In 2010, Dema received the IIMC Institute Director of the Year award. One of the testimonials submitted with the nomination stated, "Dema Harris is an incomparable, irreplaceable asset to NCI. Fall Academy 2013—A Personal Perspective

Why did I attend Fall Academy, you ask? After all, I'm an MMC; I retired, sort of; yet, I still work part time as the Clerk of a small taxing district. In my mind, I have the best of both worlds. The topic of this year's Fall Academy, *When the Role of Advisor and Decision-Maker Intersect*, is so appropriate to what I am doing now. But there was one more thing that inspired me to attend.

I have long stood before you and told you that I see things in you that you don't see in yourselves. I see leaders, many of them. I see very smart, competent people who are often given little credence. I see others whose cities would sputter if they were to leave, or, who see to it that their cities soar when a valued manager leaves. I see the future of WMCA. So when one of the lead statements from Janice Corbin, the presenter for the Academy, was *how much Clerks can inspire those around us*, even those elected and appointed officials that could negatively influence

our career paths if they so desired, I was all ears. What would she say?

You see, I happen to agree with her - in spades! And we clerks need to learn to see it in ourselves, too, and begin to actively and consciously influence those around us.

Ms. Corbin stated that clerks have a lot of influence that they leave on the table simply because they do not recognize how much they know and that they can actually contribute; translated, that means, you, too, can *influence* appointed and elected officials in process, procedure, and culture. Too few of the appointed and elected officials recognize the value of their clerks to them. As I go about mentoring my colleagues at this point in my career, I join Janice Corbin in emphasizing this to the clerks I interact with and encourage them to ask leading questions with the intent of influencing their counterparts.

By sharing the best and the most recent new information, colleagues from all levels can influence others. It has been a personal belief of mine for a long time that clerks have much more influence than they realize and that their knowledge and influence CAN and SHOULD be used to their advantage to influence those around them. What a validating presentation Ms. Corbin offered.

But there was more. I do believe in life-long learning and I had never had the steps to problem solving laid out before me. I don't know about y'all, but the blame game when something goes wrong is such an exercise in futility. My take is that we just fix what didn't work. But, where to begin? We learned problem solving on two levels.

Simple Problem-Solving Model

- What is the problem?
- What is the desired outcome?
- Who are the stakeholders (those impacted by a problem & the solution)?
- What data, information, facts, and policies need to be gathered?
- Who is responsible or has the authority to make the decision?
- How and when will the results of the solution to the problem be evaluated?

More Complex Problem-Solving Model

- How did the problem come to your attention? Or "Why is it important to solve the problem?"
- What is the objective of solving the problem?
- Are there any other aspects of the problem that may be worth solving?
- What is the status of the problem now (outcome) and what is the preferred result (or desired outcome)?
- Have all the important factors or aspects of the problem been identified? (policies, procedures, rules, limitations, budget limitations)
- After doing this work, restate the problem in its simplest form.
- Have you checked your assumptions?
- Remember 20% of the problems encountered are system-related problems and 80% are people-specific. How have others that faced similar situations resolved the problem?
- What is the shortlist of possible solutions to the problem?
- What criteria will you use to determine if the solution to a problem was successful (how will you evaluate the effectiveness of the solutions to the problems)?
- Implement the decision or solution to the problem.
- Evaluating the solution to the problem to determine what was successful and what may be done differently.

And if you think about problem solving and decision making as similar and interrelated things, following these two simple models makes perfect sense. Problem-solving is about looking in the rear-view mirror and attempting to determine what decisions were made or not made that resulted in a problem surfacing. Decision making is the process of looking at what is before us and what decision or actions need to be taken so the problem is resolved or doesn't reoccur.



And while you might not find me at every class or Academy, I am committed to staying current and to keep on learning. You are never too old or too knowledgeable to learn new information or methods.

The criteria for the Clerk of the Year nomination include:

- Eligible nominees shall be active WMCA members (fully paid dues) for the preceding five consecutive years.
- The nominee must have made significant contributions or performed outstanding service to WMCA, to the profession of municipal clerk, and to his/her individual municipality in the following areas:
 - ◇ Leadership, organization, administration and communications.
 - ◇ Legislative and governing body procedures, records management and public relations.
 - ◇ Outstanding service to WMCA (time/length of service; service on WMCA Committees, attendance at state conferences, involvement in regional groups and/or IIMC committees) and contribution to the clerk profession.
 - ◇ Special projects and community activities and volunteerism.



Please note that it is encouraged that nominations be submitted in collaboration with the nominee's elected and/or appointed officials and/or supervisor. The only WMCA members not eligible to be considered for nomination are those holding the office of President, President-Elect, Vice President and Past President.

-Candidate Packet Deadline: December 31, 2013-

The Elections Officer and the Membership Committee have announced the annual call for candidates to fill board positions on the WMCA Executive Committee. Service in these positions is a great way to fill service requirements for IIMC certifications and a fun way to be involved in the educational, planning and advocacy activities of the Washington Municipal Clerks Association.

The election will be held from January 31 through February 21, 2014 through electronic voting software. The following positions are available in this election:

- **President Elect (1-year term)**
- **Secretary (2-year term)**
- **Vice-President (1-year term)**
- **2 Board Member positions (3-year term)**

Job descriptions for the positions can be found at www.wmcaclerks.org/ecpositions (under the Executive Committee tab) as well as complete instructions for declaring your candidacy.

Candidate Packets must be received by the Elections Officer (Leana Johnson, City of White Salmon) no later than Tuesday, December 31, 2013. An electronic copy of the application materials is welcome; however, the signed originals of the Declaration of Candidacy and the Letter of Support must be provided in hard copy and received by the December 31st deadline.

Candidate Packets **must** include the four following pieces of information:

1. **Declaration of Candidacy:** This is a signed, written document containing the following:
2. *"I declare myself as a candidate for the office of _____ . I declare that I am an active WMCA member in good standing. I request that my name be printed on the official ballot for election. Attached is a letter of support from my (mayor, city manager, city/county administrator or CEO), with a photo and candidate statement which I authorize for use in the election process."*
3. **Candidate Statement:** This statement must be no more than 200 words in length, including your name, title, place of employment and a statement of why election to office is sought and must be submitted with your Candidate Packet. All words of more than one letter, all groups of numbers, and abbreviations or acronyms will be counted as one word.
4. **Photo:** A (2" x 2") black and white or color digital photo of you must be submitted with your Candidate Packet.
5. **Letter of Support:** A letter addressed to WMCA and signed by your mayor, city manager, city/county administrator, or CEO supporting your candidacy and your increased involvement in WMCA must be submitted with your Candidate Packet.
