LEGISLATIVE COMMITTEE REPORT

During the 2009 Legislative Session, the WMCA Legislative Committee monitored 47 bills of interest to Clerks across the state, covering topics across the gamut from public records, public disclosure, and open public meetings, to special elections and campaign contributions. This was a "long session" that ran from January 12 through April 26, 2009.

Highlights of bills we tracked that passed:

- SSB 5130 addresses the filling of public disclosure requests by prisoners at a level deemed to be harassment. This bill was initiated by the scores of requests filed by inmate Alan Parmelee at a variety of agencies. It allows Courts, upon motion by cities (and other public agencies), to prohibit the examination of public records if the Court finds the request was made to harass or intimidate the city or its employees. The Court may also enjoin future requests by the same inmate, and the agency is not liable for penalties during the time the court injunction is in place.
- SHB 1552 initially would have required that all public meetings be recorded and that formal public testimony be received prior to the adoption of ordinances, resolutions, and rules, etc. This bill was later amended to apply only to agency rule-making hearings, which eliminated its application to cities. (It is mentioned here only because bills that are somehow restricted in application often resurface with broader applicability at later a Legislative Session.)

 ESHB 1018 eliminated the March special election opportunity, leaving February, April and May as options for cities, school districts or other special districts needing to place ballot measures before the voters.

Highlights of bills we tracked (and on which we provided feedback) that failed:

- HB 1676 required that, for agencies found to have violated the Open Public Meetings Act, the agency would be required to tape executive sessions for two years. The Auditor and Attorney General would be authorized to appoint a committee to recommend Model Rules and recommend penalties for violations. (This bill is likely to return in 2010)
- HB 1017 would have created a committee to study creation of a Public Records/Open Public Meetings Act Board that would have independent authority to adjudicate complaints of violations and enforce provisions of the PRA and OPMA. This Board could also issue interpretive opinions or recommend legislation. The idea was that it would be constructed along the lines of the Sunshine Committee, which could potentially have resulted in significant representation from the news media.
- HB 1784 would have given authority to the Public Disclosure Commission to enforce the
 Open Public Meetings and Public Records Acts.
- HB 1317 would have eliminated the need to disclose personal information about criminal
 justice employees, such as their home addresses, phone numbers, birth dates and photos.
 (This bill is likely to return in 2010)
- HBs 5249, 5250, and 5251 would have allowed cities to deny a public records request if
 the requesting party had unpaid charges from previous requests, increased the maximum
 charge to 25 cents per page, and allowed charging for all photocopies made to fill a
 request, regardless of the number of pages actually taken by the requestor.
- SB 5295 would have adopted the eight unanimous recommendations from the Sunshine
 Committee that was established in 2007 by the Legislature to review and make
 recommendations on 300 current exemptions from public disclosure.

Aside from tracking and providing information to AWC and legislators during the Legislative Session, much of the work of the Legislative Committee this year has been spent on seeking to proactively work as individuals and in groups to educate ourselves and others on possible legislative reforms that can be lobbied with particular Legislators over time. Many of our issues relating to public records/meetings and our ability (or lack thereof) to comply with the body of current law are being heard and understood by local elected and appointed officials, and it appears we may have an opportunity over the next few years to work together to help craft new, more workable legislation while remaining steadfast to the citizens' value of open government that we espouse.

Some developments along those lines include:

- Executive Board member Sandy Paul and I represented WMCA on the AWC Legislative Committee and their Flexible General Government Operations Sub-Committee. The Sub-Committee voted to retain the 2009 priority to oppose any requirements to tape executive sessions and any restrictions on attorney-client privilege or attorney work product. Records-related issues surfaced as a very high priority for the group, and when the total list of all General Government issues was prioritized, pursuing proactive proposals to address problems associated with request volumes was voted the second highest priority to forward to the full AWC legislative Committee. AWC concurred and also identified that they would participate in a coalition with other local governments/agencies to craft solutions.
- The Sub-Committee identified a number of ways to strategically approach possible legislative reforms over time to help build a climate where workable solutions can be crafted. Thoughts include:
 - O Quantifying the true costs of responding to public disclosure requests
 - Educating legislators and the public on these costs
 - Providing a "meet and confer" option to address problem requests, similar to discovery during litigation
 - Reforming the penalties
 - Further addressing the harassment issue

- Allow charging for records-finding services under some circumstances (perhaps along the lines of what is being done by FOIA)
- Clarifying treatment of metadata and content of blogs, wikis, and other social media.
- In keeping with the notion of quantifying the true costs of responding to public disclosure requests, Kyle Stannert, Bellevue's Public Records Officer, shared his background research for his MPA capstone project with the King County Clerks Association in October. As part of his project, Kyle surveyed (filed records requests) the 20 largest cities and a number of state agencies and then statistically analyzed the numbers and kinds of requests they have been receiving as well as the sources of the requests. His findings included that, although on a volume basis members of the public initiate the greatest numbers of requests, it turns out that the most complex requests that reflect the greatest response times and, most likely, staff resources to respond are being filed by businesses, attorneys and the press. Such documentation, if collected in a more comprehensive manner, may help to bolster the case for permitting fees to cover costs of responding to larger records requests. The Legislative Committee would welcome feedback from Clerks across the state on their willingness to participate in a broader survey to gather and analyze this sort of information.
- A new professional organization, the Washington Association of Public Records Officers (WAPRO) formed in late 2009 to help leverage the knowledge and experience of public employees in working with the Public Records Act. Their stated aim is to increase transparency and improve PRA compliance by making standardized education and resources available to jurisdictions of varying sizes and degrees of resources. This association will also serve as a forum for Records Officers to network and share best practices, discuss technology and tools to track and provide records, and keep jurisdictions informed about new case law and legal developments as they occur.
- The Sunshine Committee actually took up for discussion the current exemption from public disclosure that the Legislature has granted itself. Were the Legislature to rescind their

exemption and individual Legislators and their staffs be compelled to comply with the law as written, they might more fully understand the resource commitments needed to comply and the impacts of new technologies. There is hope, since this issue is becoming more public, that we might pursue more reasoned approaches by working together to achieve transparency at a reasonable cost.

• The Attorney General has opined to the State Auditor and in the press about the need for state employees to maximize use of technology to enhance government transparency to allow for meaningful participation in self-governance. The Legislative Committee members feel that the case should continue to be made, particularly in these straitened economic times, that many of the larger cities are working hard to implement technology solutions, but we cannot leave our smaller cities/agencies behind. Sharing technology and best practices can go some way to helping to level the playing field, but does not address the resource limitations felt by most small cities. This message needs to continue to be played out with the AG, State Auditor, and our Legislators.

As we concluded the year, the Legislative Committee was gearing up for the 2010 short session that began in early January. As expected, many of the bills not passed during 2009 were reintroduced in the December timeframe, together with some new legislation. We are continuing the monitor the progress of the 2010 Legislative Session as it winds to a close this month, and will report back shortly on the latest developments.
