RULING FINDS FACEBOOK POSTS CAN BE A PUBLIC RECORD

A February ruling in the Washington State Court of Appeals clarified the circumstances under which personal Facebook posts can be considered public records. The court held that "a public official's posts on a personal Facebook page can constitute an agency's public records subject to disclosure under the PRA if the posts relate to the conduct of government and are prepared within a public official's scope of employment or official capacity." The court also held that the Puyallup City Councilmember Julie Door's personal Facebook posts related to city business and were not public records.



Julie Door's posts fell under three categories:

- References to various city issues;
- References and links to posts on the city's Facebook page about various city issues; and
- References and links to the Puyallup Police department's Facebook page.

The analysis focused on whether the posts met the three elements of a public record in RCW 42.56.010(3):

- 1) "any writing"
- "containing information relating to the conduct of government or the performance of any governmental or proprietary function"
- 3) "prepared, owned, used, or retained by any state or local agency"



They were able to conclude that the posts were "writings" and that at least some of the posts were related to the conduct of government or a government function. The court then turned to whether the City of Puyallup "prepared" Councilmember Door's Facebook posts but concluded they had not been prepared by the city.

This is an important case for elected officials and employees who maintain their own personal Facebook page and occasionally post about agency business. In this case, the court provided some

good direction on what types of social media posts constitute a public record. In the future, when your agency receives a request for personal Facebook posts, do a careful review of West v. City of Puyallup.


